## I. Purpose and Processing of Your Data

#### 1. Newsletter

The legal basis for processing this data is the performance of a contract (Article 6(1)(b) GDPR).

Additionally, your data, along with the IP address used to subscribe, will be stored on the server of the mailing service provider with whom the Administrator has a data processing agreement. Your data will be used to send you the requested content and will remain in the database for the duration of the newsletter service, unless you terminate the service, in which case your data will be deleted.

#### 2. Contact Form

You can contact us by submitting an inquiry via the contact form available on our website. In this case, you provide us with your name, email address, company name, address, Tax Identification Number (NIP), and other information in the message content that may include personal data. Providing this data is voluntary but necessary to establish contact via the form.

Your data will be processed for the following purposes:

Responding to your inquiry, i.e., actions requested by the data subject (Article 6(1)(b) GDPR);

Archiving, which is our legitimate interest (Article 6(1)(f) GDPR);

Possible claims or defense against claims, which is our legitimate interest (Article 6(1)(f) GDPR).

You have the right to access the correspondence history (if archived) and request its deletion, unless its archiving is justified by overriding interests of the Administrator, such as defense against potential claims. Data will be processed until the purpose of processing ceases.

# 1. Log Files

Each time you visit our website, the system automatically collects information and data from your device. The legal basis for processing this data is the Administrator's legitimate interest (Article 6(1)(f) GDPR).

Your data is stored on the server until it is no longer necessary for the purpose for which it was collected. If the data is collected to provide the website service, it will be deleted when the session ends. Log file data is essential for the website's operation, and thus, users cannot object to its processing.

#### 2. Google Analytics

To analyze how users interact with our website, we use Google Analytics, a service provided by Google Ireland Ltd. (Gordon House, 4 Barrow Street, Dublin, Ireland). This tool enables us to create activity reports, measure content effectiveness, and provide other internet usage insights.

Google Analytics uses cookies, which are text files stored on your device. The information collected by these cookies is typically sent to Google's servers, where it is stored. To protect your privacy, we use IP anonymization, ensuring that your IP address is shortened, making it impossible to link the address to you directly.

The legal basis for processing this data is the Administrator's legitimate interest (Article 6(1)(f) GDPR). Data will be retained by Google for 26 months. Due to IP anonymization, no personal data will be stored. You can block cookie storage on your device through your browser settings or by using a browser plugin to disable data transmission to Google.

#### 3. Facebook Pixel

To analyze, optimize, and improve our services, we use Facebook Pixel, provided by Facebook Ireland Ltd. (4 Grand Canal Square, Grand Canal Harbour, Dublin 2, Ireland). Facebook Pixel is a piece of code embedded in our website that helps us measure the effectiveness of Facebook advertisements by tracking users who visit our services after clicking on a Facebook ad.

III. Your Rights as a Data Subject

4. The right to withdraw consent for processing your personal data for specific purposes, if consent has been previously given.

In certain situations, where the law requires us to share collected data with state authorities, we will be obliged to provide such data. Additionally, the Administrator may share your personal data with service providers such as accounting firms, legal service providers, IT service providers supporting the website, email service providers, and web hosting providers.

V. Transfer of Data Outside the European Economic Area (EEA)
